



- is a Cloud-Based Customizable Quality Management Tool and a Mobile APP for Data-Entry and Data-Analysis
- to Monitor Hand Hygiene Adherence To My 5-Moments & Infection Precautions
- for Infection Prevention & Control Professionals and Healthcare Quality Managers who are trained in the World Health Organization hand hygiene observation method.

User Role Institutional Manager

Has Access to Web-Admin-Tool and Mobile APP



Web-Admin Tool

- Create/edit users
- Create/edit locations
- Set timeline & targets for auditors and check fulfillment rate
- Generate and filter reports
- Download reports, raw data & user lists




Mobile APP

- Record observations
- Generate and filter reports by location, user and health care worker type



User Role *Auditor* has Access to the APP, only.



Sees targets (if there are any), fulfillment rate & recorded observations.

Can perform Hand Hygiene Compliance Observations



For the user role **Auditor** the selection of other Auditors is blocked! Data entered by other Auditors <u>cannot</u> be seen.




Monitoring «My 5-Moments» Moment 4 and 5 cannot be recorded together. Select Moment 1-5 by tapping on the arrows.



Link an ACTION to the selected Moments








Main Features Mobile APP Monitoring My-5-Moments for Hand Hygiene

- 1. Enter the target number of observations to be met during this observation.
- 2. Select location
- 3. Select HCW (Health Care Worker) Type
- 4. Begin Audit
- 5. Click on the arrows (Moments) and record action, add notes, precaution measures if indicated then press Submit.
- 6. Record more hand hygiene opportunities
- 7. After completing the observations provide educational feedback to the observed HCW




Main Features Mobile APP Monitoring Additional Precautions







Data Security

The application is served via HTTPS to ensure integrity and confidentiality of data between the user's computer and the site.

The login system flags a user account and locks the account after several failed login attempts. It is currently configured to 5 attempts.

After 15 minutes idle time (no activity on the Web-Admin-Tool) the user is logged off automatically.

Email address of the user field is stored encrypted in the database.

Administrators (Employees from B. Braun) can set up and edit accounts for institutions and users. Recorded HH-compliance data or locations is inaccessible for B. Braun employees.
